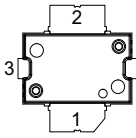
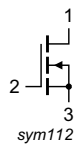

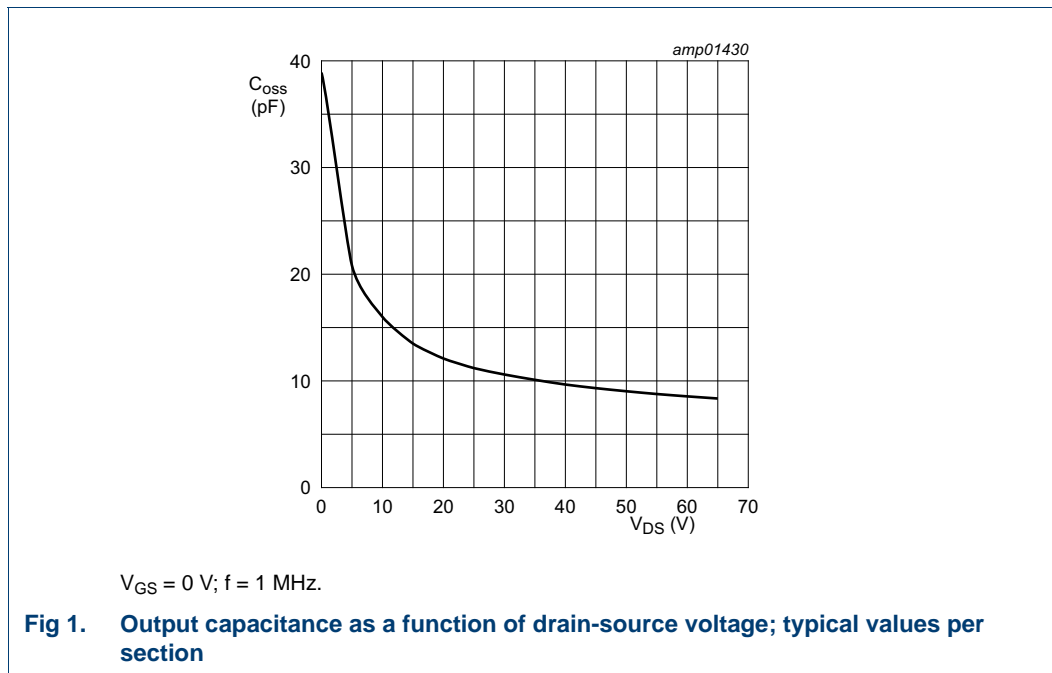

## 7. Test information

### 7.1 Ruggedness in class-AB operation

The BLP15H9S30 is capable of withstanding a load mismatch corresponding to VSWR = 30 : 1 through all phases under the following conditions:  $V_{DS} = 55\text{ V}$ ;  $I_{Dq} = 10\text{ mA}$ ;  $P_L = 47\text{ W}$ ;  $f = 1400\text{ MHz}$ ; pulsed CW ( $t_p = 100\text{ }\mu\text{s}$ ;  $\delta = 20\%$ ).

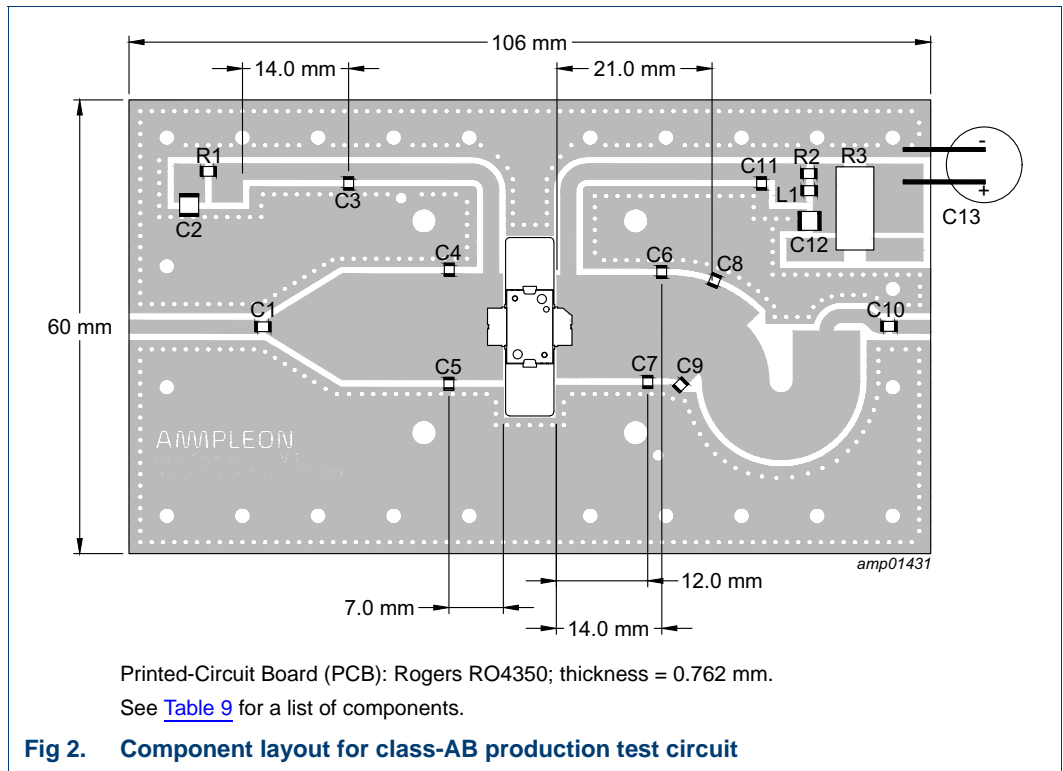


Fig 2. Component layout for class-AB production test circuit

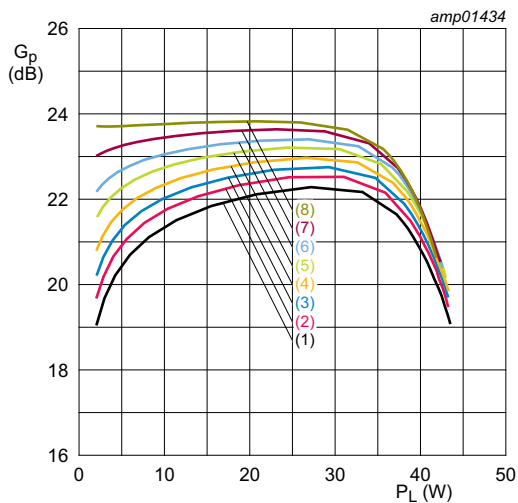

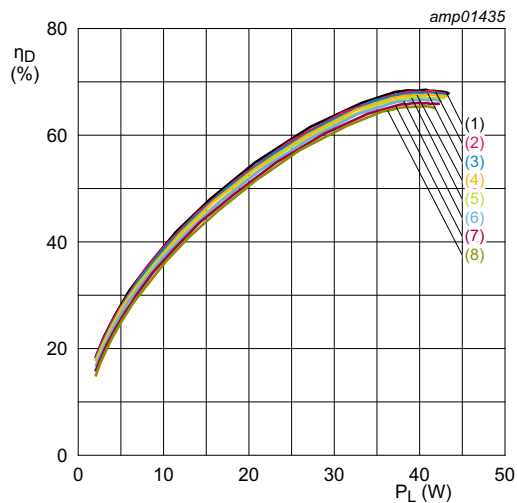

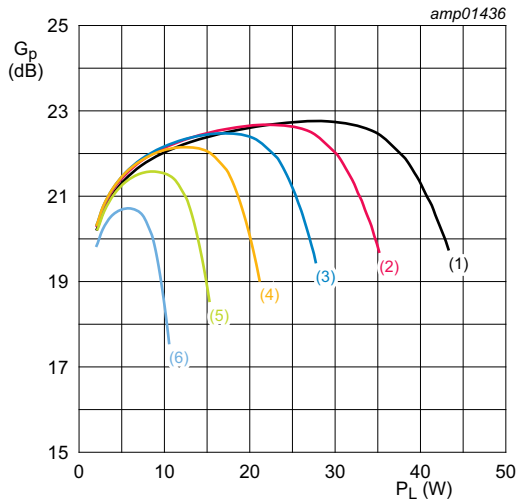
**Fig 5. Power gain as a function of output power; typical values**

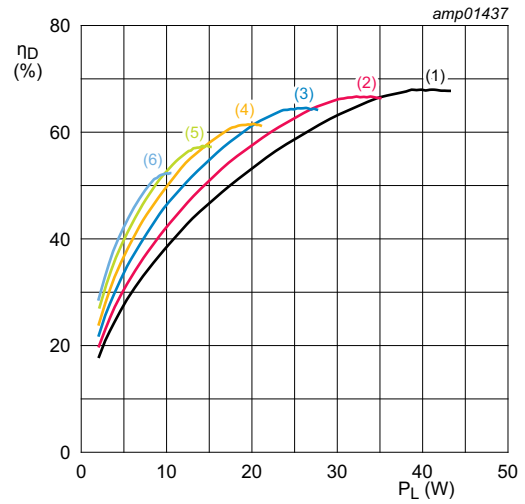
**Fig 6. Drain efficiency as a function of output power; typical values**

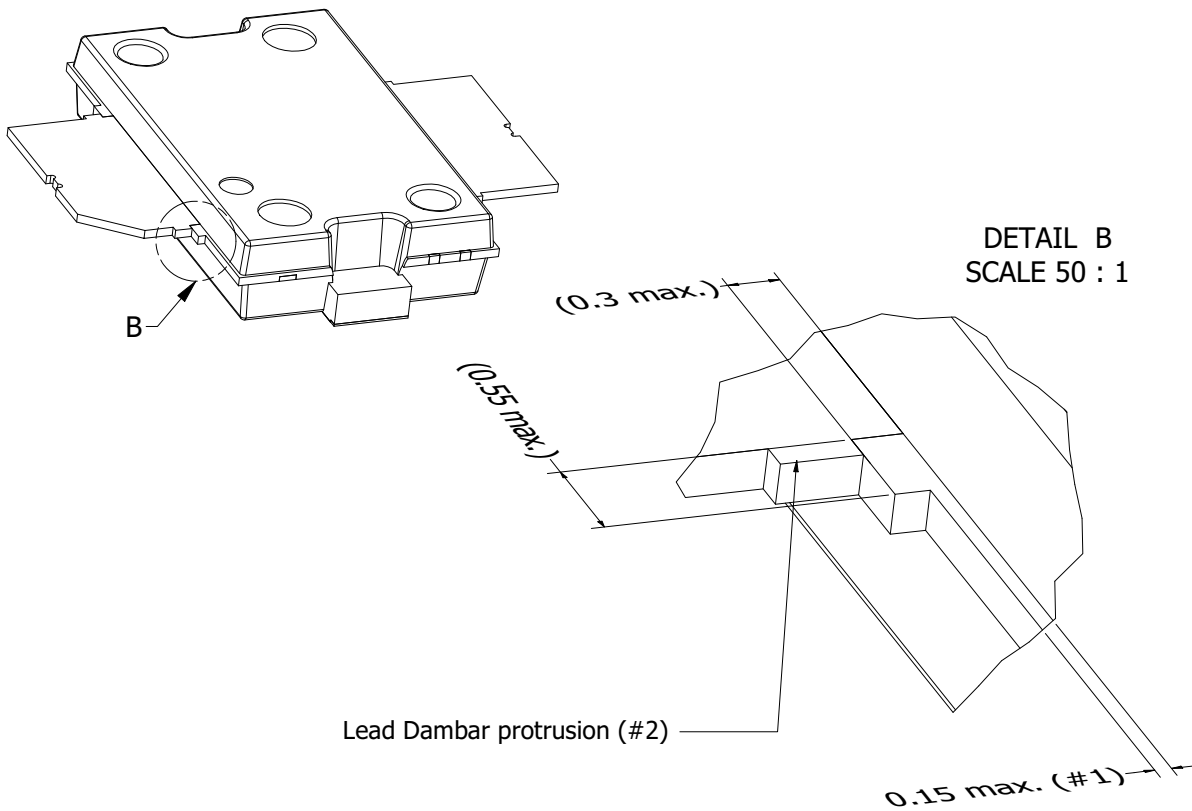
**Fig 8. Drain efficiency as a function of output power; typical values**
